AARP Fraud Watch Network Offers Resources to Help Prevent ID Theft and Fraud

AARP has mounted a local campaign to fight identity theft and fraud through its AARP Fraud Watch Network. Identity theft and other forms of fraud pose a serious threat in Arizona. Fraud and scams cause billions of dollars in losses nationwide every

year. According to the Federal Trade Commission, Arizona ranks seventh in the nation for I.D. Theft complaints. The AARP Fraud Watch Network is designed to give Arizonans access to information to help protect them and their families from theft and fraud. "It is free and open to everyone - members, non-members, and people of all ages. It allows people who sign up access to watchdog alerts about active scams in their area and resources to help them spot and avoid con artists' latest tricks," said David Parra, AARP Arizona Associate State Director.

The AARP Fraud Watch Network contains valuable information about the way scammers think and how they target their victims.

2016 Aging In Arizona State Conference

Adult Protective Services Registry

Did you know that the Adult Protective Services (APS) Registry has been available to the public online since April 1, 2015? This is a great resource and tool for individuals looking to hire their own caregiver or for screening volunteers who will be working with vulnerable populations.

The original concept of the registry goes back to July 2007, when the Appeals process and the APS Registry were enacted. Certain requirements had to be upheld before a name could be legally placed on the registry, as APS must provide due process for alleged perpetrators. Once a "preponderance of the evidence" is established to substantiate the allegations, the perpetrator's name is placed on the APS Registry for 25 years. The registry lists the name of the registered perpetrator and a description of the disposition. It is updated every Monday. It is located online at https://des.az.gov/services/aging-and-adult/arizona-adult-protective-services-aps.

If you ever suspect that an adult is being abused, neglected, or financially exploited, please contact APS at the statewide toll-free telephone reporting line 1-877-767-2385, Monday-Friday 7 a.m. - 7 p.m. / Saturday-Sunday 10 a.m. - 6 p.m., or you can file an online report 24 hours a day, seven days a week at https://des.az.gov/services/aging-and-adult/adult-protective-services/file-aps-report-online.

Grandparents Raising Grandchildren Play and Learn

"Play and Learn" classes are offered through the Grandparents Raising Grandchildren program at Chicanos Por la Causa, Inc. This is a free and fun activity where grandparents and grandchildren can spend time together. These are interactive classes where grandparents (as well as kinship caregivers) and grandchildren (birth to five years old) play, sing, dance, and have parachute and story time. While the children work on an art or craft project, the adults and an educator discuss different parenting topics that may include positive discipline, developmentally appropriate expectations, toilet training, tantrums, and so much more. At the end of the class, every child receives a free snack and book.

This is an opportunity for other grandparents and caregivers to connect and offer peer support. These grandparents do not necessarily have to have custody of their grandchildren, but could be in the process of getting custody, or could just be a caregiver in their grandchildren's lives.

The evidence based curriculum *Nurturing Parenting* is used and certificates of completion and letters of attendance are provided, if needed, for court or foster care agencies. Congratulations are in order! The Arizona Caregiver Coalition received its 501 (c) (3) status on October 27, 2015 and a new Executive Director has been hired.

Elizabeth Harris has worked in senior health services since 1994. After receiving a Certificate in Gerontology, she continued her formal education in this field and earned a Bachelor of Science in Aging and Lifespan Development, from Arizona State University. She continued her education in the Masters of Social Work (MSW) program and, in Fall 2011, started her MSW internship and field placement with the Foundation for Senior Living, Corporate Office.

Family Caregiver Study

The Sonoran University Center for Excellence in Disabilities Education, Research, and Service invites persons with developmental disabilities and family caregivers to participate in an interview about what is important to them in the planning of their future. The goal is to learn more about the planning process and how we can better support everyone through this experience. Updates from the Social Security Administration

I'm retiring early, before full retirement age, and I receive investment income from a rental property I own.

I've heard there's a limit on income I can make if I retire early. Does investment income from my rental property count as earnings for Social Security purposes?

Answer: No. We count only the wages you earn from a job or your net profit if you're self-employed. Non-work income such as annuities, investment income, interest, capital gains, and other government benefits are not counted and will not affect your Social Security benefits. Most pensions will not affect your benefits. However, your benefit may be affected by government pensions earned through work on which you did not pay Social Security tax. You can retire online at www.socialsecurity.gov. For more information, call us toll-free at 1-800-772-1213 (TTY 1-800-325-0778).

I was turned down for disability. Do I need a lawyer to appeal?

Answer: You're fully entitled to hire a lawyer if you wish to, but it is not necessary. In fact, you can file a Social Security appeal online without a lawyer. Our online appeal process is convenient and secure. Just go to www.socialsecurity.gov/disability/appeal. If you prefer, call us at 1-800-772-1213 (TTY 1-800-325-0778) to schedule an appointment to visit your local Social Security office to appeal.

My grandfather, who is receiving Supplemental Security Income (SSI), will be coming to live with me. Does he have to report the move to Social Security?

Answer: Yes. An SSI beneficiary must report any change in living arrangements within 10 days after the month the change occurs. If the change is not reported, your grandfather could receive an incorrect payment and have to pay it back, or he may not receive all the money due. Just as importantly, your grandfather needs to report the new address to Social Security to receive mail from us. You can report the change by mail or in person at any Social Security office or call Social Security's toll-free number at 1-800-772-1213 (TTY: 1-800-325-0778). You can get more information by reading the booklet *Understanding SSI*, at www.socialsecurity.gov/ssi.

I am trying to save up for a truck. I have \$1,200 in the bank now and need a little more. How much cash can I have in the bank without affecting my Supplemental Security Income (SSI) eligibility?

Answer: The resource limit is \$2,000. Unless you have other valuable resources, this means you could save up to \$2,000 before you would become ineligible for SSI. We generally do not count your primary vehicle, the home you live in or certain amounts set aside for burial expenses as resources. If you are in this situation, call Social Security at 1-800-772-1213 (TTY users should call 1-800-325-0778) or visit any Social Security office.



People who sign up as part of the 'Fraud Watch Network' also receive timely alerts and notifications about new scams as they emerge, as well as information about what to do if you, or someone you know, is victimized.

"Whether it is over the phone, through the mail, online, or even at your door, scam artists are out there and they are looking for ways to get you and your loved ones to open your wallets," added Parra. "The AARP Fraud Watch Network offers information to help protect you and your family from falling victim to fraud and scams."

Presentations on fraud prevention are also offered through AARP Arizona. Volunteers with the AARP Fraud Watch Network are available to provide presentations to groups, senior centers, and at libraries. "We have volunteers who can give fraud prevention presentations in many areas of the State," added Parra.
